### New important update to version 6.0.6

That's the reason why [the new version 6.0.6](#) doesn't just contain corrections but also some important new features. Among the most important ones, we highlight the new option "*Export as data*" in the dialogue window Export rows to Html, Xml and in the command line.

In the *Accounting report* (in the header of the segment column) the description of the segment can also be read. What's more, the accounts without a balance, but with an earlier balance, are being displayed. In the Enhanced balance sheet by groups, we have made it possible for a balance that is expressed in foreign currency, to also be displayed when a determined period has been selected.

The new Swiss VAT form has been issued and is valid from on 01.07.2010. It includes both the VAT percentages that are still applicable for the year 2010, as well as those for the year 2011. Banana has published a new style sheet that enables the user to process the VAT according to the most recent criteria.
